PURPOSE COMMERCIAL INFORMATION TECHNOLOGY SOFTWARE**

1. INSPECTION/ACCEPTANCE

The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The ordering activity reserves the right to inspect or test any software that has been tendered for acceptance. The ordering activity may require repair or replacement of nonconforming software at no increase in contract price. The ordering activity must exercise its postacceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the software, unless the change is due to the defect in the software.

2. GUARANTEE/WARRANTY

a. Unless specified otherwise in this contract, the Contractor's standard commercial guarantee/warranty as stated in the contract's commercial pricelist will apply to this contract.

ROH warrants for a period of three months after the date of purchase that the operation of supported configurations of OCULUS software on an appropriately configured functional computer and environment will perform in substantial compliance with the Documentation supplied.

b. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

c. Limitation of Liability. Except as otherwise provided by an express or implied warranty, the Contractor will not be liable to the ordering activity for consequential damages resulting from any defect or deficiencies in accepted items.

3. TECHNICAL SERVICES

The Contractor, without additional charge to the ordering activity, shall provide a hot line technical support number **800.995.3516** for the purpose of providing user assistance and guidance in the implementation of the software. The technical support number is available from **8am – 5pm EST (Eastern Standard Time)**

4. SOFTWARE MAINTENANCE

a. Software maintenance service shall include the following:

_____ 1. Software Maintenance as a Product (SIN 132-32 or SIN 132-33)

Software maintenance as a product includes the publishing of bug/defect fixes via patches and updates/upgrades in function and technology to maintain the operability and usability of the software product. It may also include other no charge support that are included in the purchase price of the product in the commercial marketplace. No charge support includes items such as user blogs, discussion forums, on-line help libraries and FAQs (Frequently Asked Questions), hosted chat rooms, and limited telephone, email and/or web-based general technical support for user's self diagnostics.

Software maintenance as a product does NOT include the creation, design, implementation, integration, etc. of a software package. These examples are considered software maintenance as a service.

Software Maintenance as a product is billed at the time of purchase.

X 2. Software Maintenance as a Service (SIN 132-34)

Software maintenance as a service creates, designs, implements, and/or integrates customized changes to software that solve one or more problems and is not included with the price of the software. Software maintenance as a service includes person-to-person communications regardless of the medium used to communicate: telephone support, on-line technical support, customized support, and/or technical expertise which are charged commercially. Software maintenance as a service is billed arrears in accordance with 31 U.S.C. 3324.

- b. Invoices for maintenance service shall be submitted by the Contractor on a quarterly or monthly basis, after the completion of such period. Maintenance charges must be paid in arrears (31 U.S.C. 3324). PROMPT PAYMENT DISCOUNT, IF APPLICABLE, SHALL BE SHOWN ON THE INVOICE.

5. PERIODS OF MAINTENANCE (132-34)

- a. The Contractor shall honor orders for periods for the duration of the contract period or a lesser period of time.
- b. Maintenance may be discontinued by the ordering activity on thirty (30) calendar days written notice to the Contractor.
- c. Annual Funding. When annually appropriated funds are cited on an order for maintenance, the period of the maintenance shall automatically expire on September 30 of the contract period, or at the end of the contract period, whichever occurs first. Renewal of the maintenance orders citing the new appropriation shall be required, if the maintenance is to be continued during any remainder of the contract period.
- d. Cross-Year Funding Within Contract Period. Where an ordering activity's specific appropriation authority provides for funds in excess of a 12 month (fiscal year) period, the ordering activity may place an order under this schedule contract for a period up to the expiration of the contract period, notwithstanding the intervening fiscal years.
- e. Ordering activities should notify the Contractor in writing thirty (30) calendar days prior to the expiration of an order, if the maintenance is to be terminated at that time. Orders for the continuation of maintenance will be required if the maintenance is to be continued during the subsequent period.

6. CONVERSION FROM TERM LICENSE TO PERPETUAL LICENSE

Contractor does not commercially offer this option therefore it is not available through this contract.

7. TERM LICENSE CESSATION

Contractor does not commercially offer this option therefore it is not available through this contract.

8. UTILIZATION LIMITATIONS - (132-33, AND 132-34)

- a. Software acquisition is limited to commercial computer software defined in FAR Part 2.101.
- b. When acquired by the ordering activity, commercial computer software and related documentation so legend shall be subject to the following:
 - (1) Title to and ownership of the software and documentation shall remain with the Contractor, unless otherwise specified.

- (2) Software licenses are by site and by ordering activity. An ordering activity is defined as a cabinet level or independent ordering activity. The software may be used by any subdivision of the ordering activity (service, bureau, division, command, etc.) that has access to the site the software is placed at, even if the subdivision did not participate in the acquisition of the software. Further, the software may be used on a sharing basis where multiple agencies have joint projects that can be satisfied by the use of the software placed at one ordering activity's site. This would allow other agencies access to one ordering activity's database. For ordering activity public domain databases, user agencies and third parties may use the computer program to enter, retrieve, analyze and present data. The user ordering activity will take appropriate action by instruction, agreement, or otherwise, to protect the Contractor's proprietary property with any third parties that are permitted access to the computer programs and documentation in connection with the user ordering activity's permitted use of the computer programs and documentation. For purposes of this section, all such permitted third parties shall be deemed agents of the user ordering activity.
- (3) Except as is provided in paragraph 8.b(2) above, the ordering activity shall not provide or otherwise make available the software or documentation, or any portion thereof, in any form, to any third party without the prior written approval of the Contractor. Third parties do not include prime Contractors, subcontractors and agents of the ordering activity who have the ordering activity's permission to use the licensed software and documentation at the facility, and who have agreed to use the licensed software and documentation only in accordance with these restrictions. This provision does not limit the right of the ordering activity to use software, documentation, or information therein, which the ordering activity may already have or obtains without restrictions.
- (4) The ordering activity shall have the right to use the computer software and documentation with the computer for which it is acquired at any other facility to which that computer may be transferred, or in cases of disaster recovery, the ordering activity has the right to transfer the software to another site if the ordering activity site for which it is acquired is deemed to be unsafe for ordering activity personnel; to use the computer software and documentation with a backup computer when the primary computer is inoperative; to copy computer programs for safekeeping (archives) or backup purposes; to transfer a copy of the software to another site for purposes of benchmarking new hardware and/or software; and to modify the software and documentation or combine it with other software, provided that the unmodified portions shall remain subject to these restrictions.
- (5) "Commercial Computer Software" may be marked with the Contractor's standard commercial restricted rights legend, but the schedule contract and schedule pricelist, including this clause, "Utilization Limitations" are the only governing terms and conditions, and shall take precedence and supersede any different or additional terms and conditions included in the standard commercial legend.

9. SOFTWARE CONVERSIONS - (132-33)

Full monetary credit will be allowed to the ordering activity when conversion from one version of the software to another is made as the result of a change in operating system, or from one computer system to another. Under a perpetual license (132-33), the purchase price of the new software shall be reduced by the amount that was paid to purchase the earlier version.

10. DESCRIPTIONS AND EQUIPMENT COMPATIBILITY

The Contractor shall include, in the schedule pricelist, a complete description of each software product and a list of equipment on which the software can be used. Also, included shall be a brief, introductory explanation of the modules and documentation which are offered.

11. RIGHT-TO-COPY PRICING

Contractor does not commercially offer this option therefore it is not available through this contract.

ROH Annual Service Agreement

POLICIES

ROH Responsibilities

- ROH warrants that all employees assigned to the execution of services under this Agreement shall be appointed in good faith and be suitably qualified in the appropriate area of expertise. ROH will ensure that its employees and agents will, whenever on Client's premises, obey all instructions and directions issued by the Client in reference to the Client's normal standard of business conduct and behaviors for those areas visited.
- The Client shall have the absolute right to disapprove each of ROH's employees whose qualifications, in the Client's good faith and judgment, do not meet the standards established by the Client as necessary for the performance of services.
- ROH warrants that its services will be of professional quality, conforming to generally accepted consulting practices.

Client Responsibilities

- The Client shall provide ROH personnel timely access to any facilities and resources required in order to perform requested services. Failure on behalf of the Client to provide timely access does not relieve the Client of the accumulation of service or expense charges.
- The Client is responsible for the execution of adequate backup and recovery procedures to ensure that the results of services are secured on a daily basis. Any loss or expense caused by inadequate backup procedures is not the responsibility of ROH.

Payment Terms

- ROH, Inc. must receive remittance for the full amount of the Annual Service Agreement before any work can be scheduled.
- A deposit may be required prior to ROH providing service in the event that the Client fails to provide payment in accordance with the terms of this agreement.
- All invoices are due and payable in full thirty (30) calendar days from the date of invoice.
- All interest payments are computed at the rate of interest established by the Secretary of the Treasury, and published in the Federal Register.
- The interest penalty shall be paid for the period beginning on the day after the required payment date and ending on the date on which payment is made.

Scheduling, Cancellation & Travel

- A minimum of five days notice is requested when scheduling, canceling, or rescheduling services.
- All non-refundable travel arrangements, cancellation and change penalties will be charged to the Client in accordance with applicable Federal travel regulations.
- Unforeseen issues that increase travel time or expenses are not the responsibility of ROH.

Limitations Of Technology

- Limitations of technology including those pertaining to customer or third party software and hardware products which extend the timeframe of services or that prohibit the delivery of services or functionality are not the responsibility of ROH.

Effective Term

- This effective term for this Agreement is for one (1) calendar year from the Commencement Date.
- A renewal notice will be submitted prior to the lapse of the effective term to prevent a break in coverage. Failure to receive payment within fifteen (15) days after the end of the effective term will result in a break in coverage. **SERVICES & RATES**

Software Upgrade Service

- The Client shall have access to "right of decimal" minor upgrades (i.e. Version 1.1, 1.2) at no charge or at a discount as provided by the manufacturers. Client must have had most recent major and minor release installed. Services not included.
- The Client shall have access to "left of decimal" major upgrades (i.e. Version 2.0, 3.0) at a discount as provided by the manufacturers. Client must have had most recent major and minor release installed. Services not included.

Phone Support

- The Client shall have access to reasonable phone support at no charge. Phone support is available from 9:00 AM to 5:00 PM EST or during normal hours of operation.

Office & On-Site Service

- The Client shall have access to services performed at any ROH office or on-site services performed at any Client facility at current published GSA contract rates. For on-site services, Travel Rates and Expenses will apply.
- When appropriate, ROH will provide Client with a proposal, quote, or estimate of the services required for a project. Such documents should not be considered as a "not to exceed" quote. All services performed for the Client including office and on-site services will be billed as recorded by technician timesheets whether or not a proposal, quote, or estimate has been provided..

INVESTMENT

- The fee for this Agreement is calculated at a percentage of the current published list price of all software products retained by the Client on the Commencement Date as indicated by ROH records for which the Client wishes ROH to provide support.
